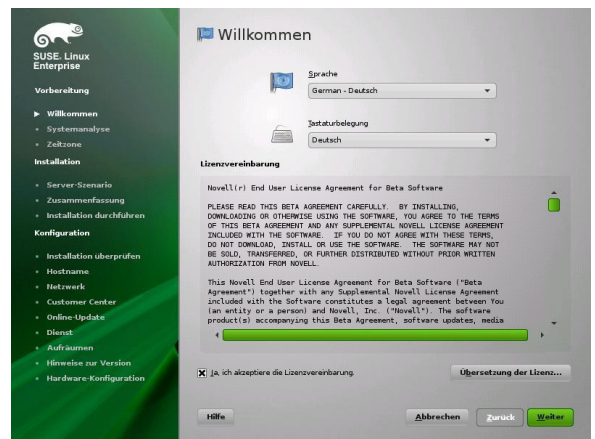
## Installation von SUSE Linux Enterprise Server

Gehen Sie entsprechend dieser Anweisungen vor, falls kein Linux-System auf Ihrem Computer installiert ist oder wenn Sie ein vorhandenes Linux-System ersetzen wollen.

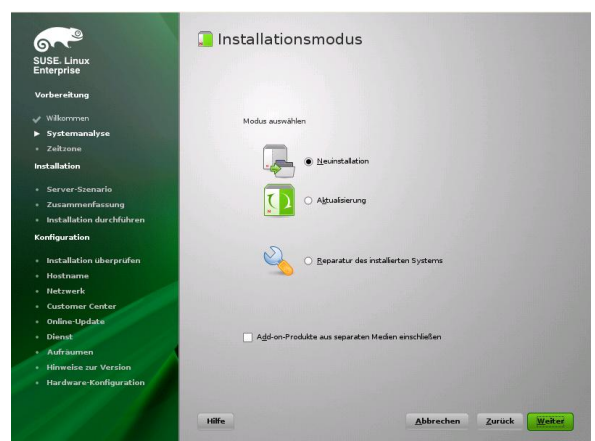
1. Legen Sie die erste DVD von SUSE Linux Enterprise Server in das Laufwerk ein und booten Sie den Computer neu, um das Installationsprogramm zu starten. Auf Computern mit herkömmlichem BIOS wird der nachfolgende grafische Boot-Bildschirm geöffnet. Auf Computern mit UEFI wird ein nicht grafischer Boot-Bildschirm verwendet. Das sichere Booten auf UEFI-Computern wird unterstützt.



2. Wählen Sie im Startbildschirm *Installation* und drücken Sie die Eingabetaste. Dadurch wird das Installationsprogramm für SUSE Linux Enterprise Server im normalen Modus gestartet.



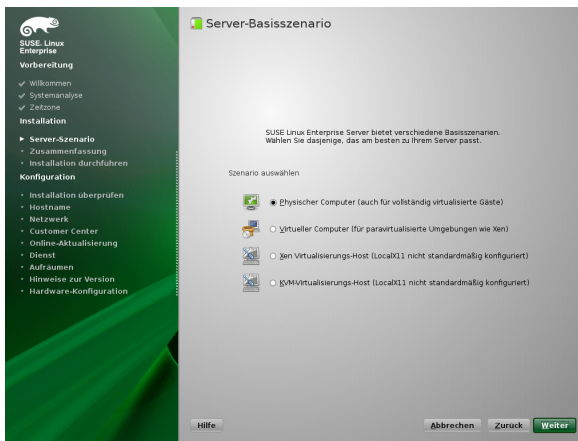
3. Wählen Sie die Sprache für die Installation und für das installierte System aus.
4. Lesen Sie die Lizenzvereinbarung und klicken Sie auf *Ja, ich akzeptiere diese Lizenzvereinbarung*. Fahren Sie mit *Weiter* fort.



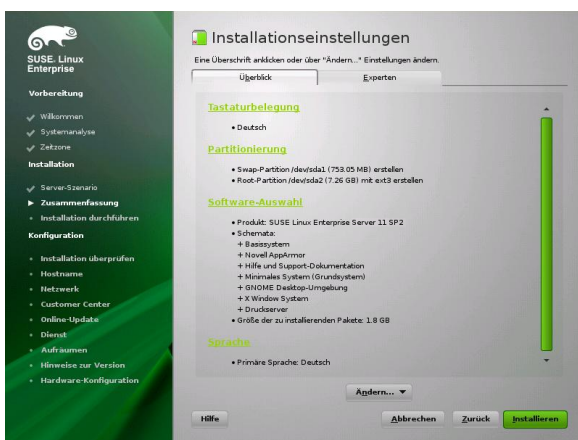
5. Wählen Sie aus, ob eine *Neuinstallation* oder eine Aktualisierung einer früheren Version von SUSE Linux Enterprise Server durchgeführt werden soll. Fahren Sie mit *Weiter* fort.



- Wählen Sie die in Ihrem System zu verwendende Uhreinstellung und Zeitzone aus. Fahren Sie mit *Weiter* fort.



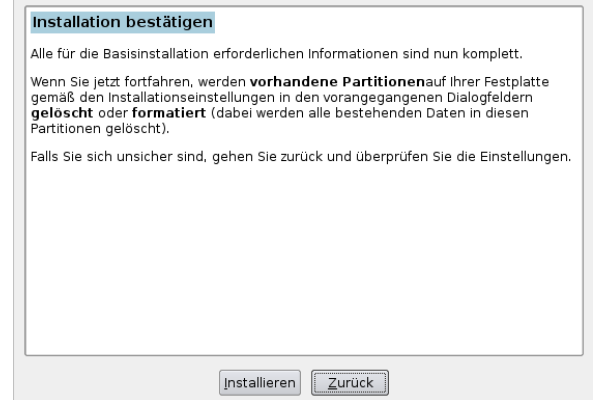
- Entscheiden Sie, ob Sie die Installation von SUSE Linux Enterprise Server auf einem *Physischen Computer* durchführen möchten, als virtuellen Gast innerhalb eines XEN-Computers durch Auswahl von *Virtueller Computer* oder als einen Virtualisierungshost, der andere virtuelle Computer mithilfe der Option *XEN-Virtualisierungshost* oder *KVM-Virtualisierungshost* ausführen kann. 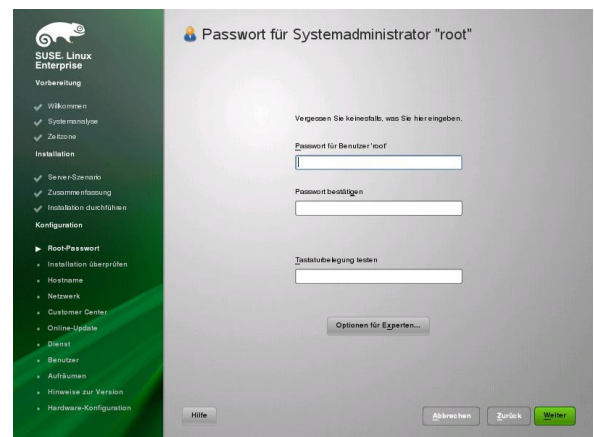

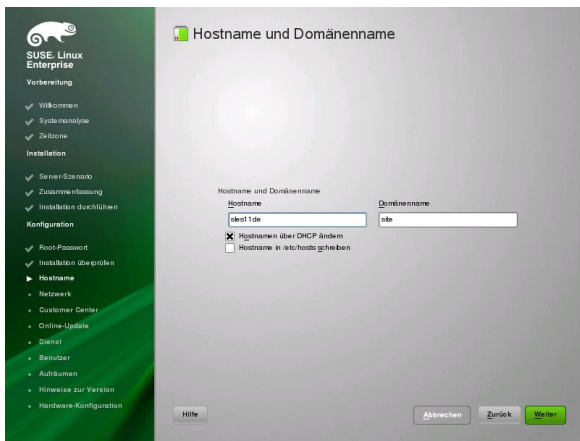
- Starten Sie die Installation mit *Installieren*.

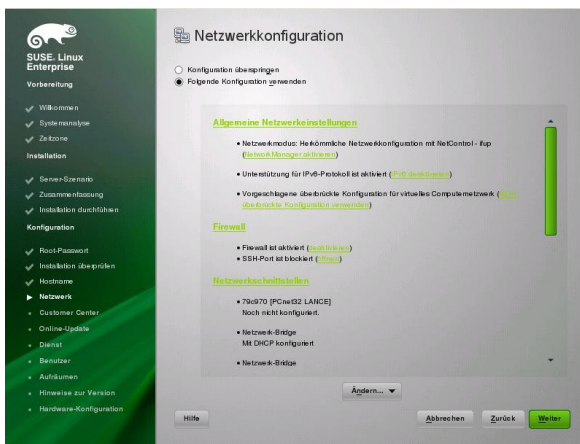


- Geben Sie ein Passwort für das Systemadministratorkonto (als *root*-Benutzer bezeichnet) ein.

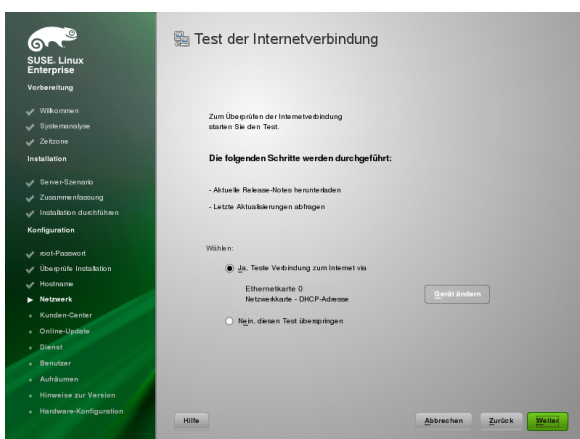

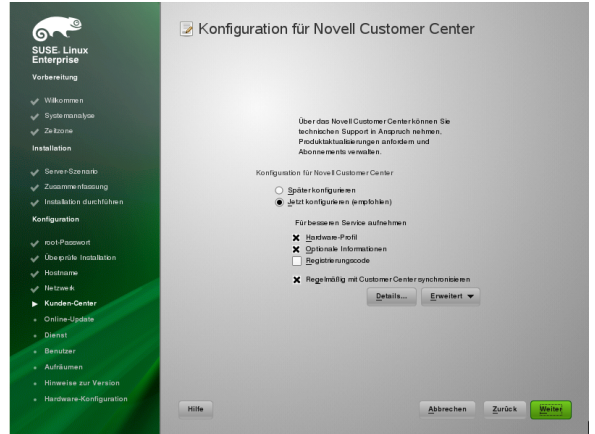


13. Im Bildschirm *Netzwerkconfiguration* können Sie die Netzwerkverbindungen Ihres Systems anzeigen und ändern.

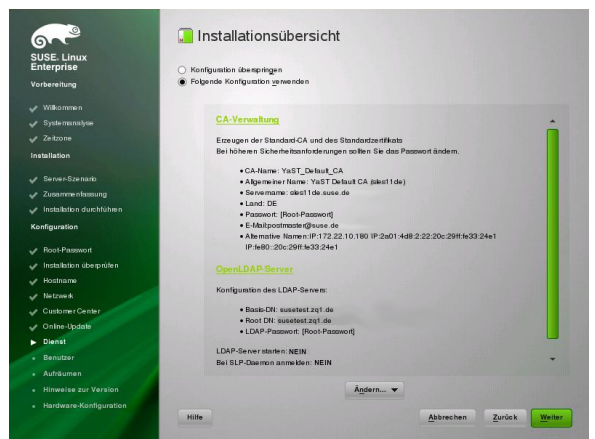

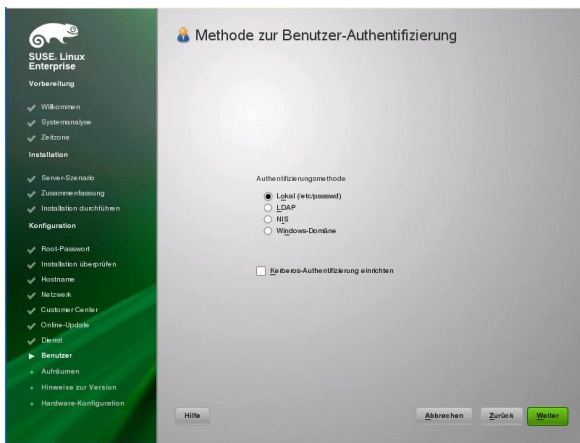

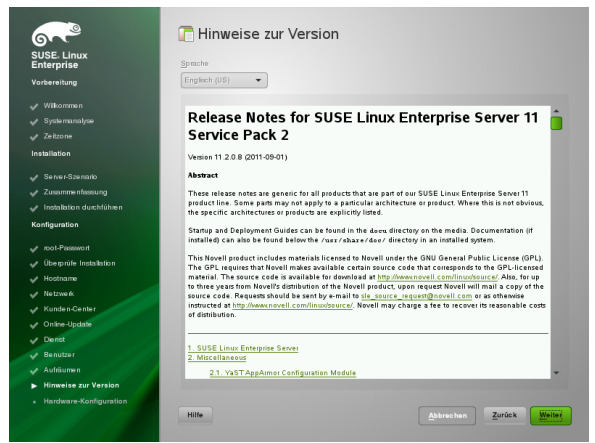

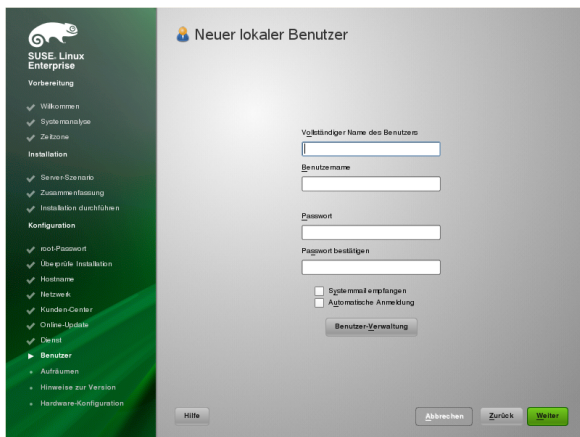

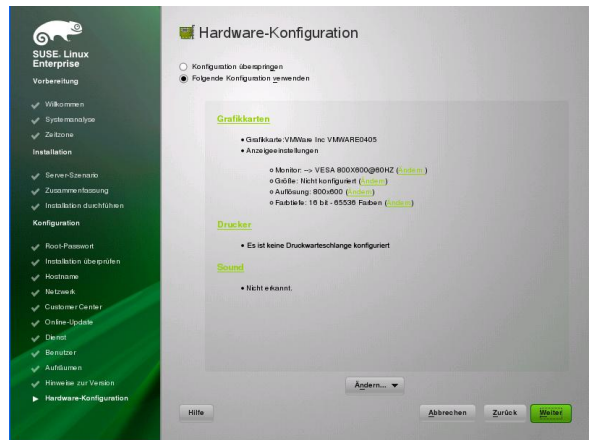


20. Sehen Sie sich nach Abschluss der Systemkonfiguration die Versionshinweise an. Fahren Sie mit *Weiter* fort.

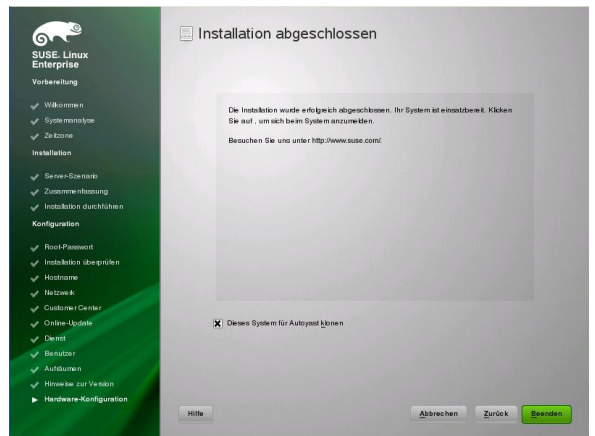


19. Geben Sie Ihren Vor- und Nachnamen in das Feld *Vollständiger Name des Benutzers* ein, Ihren Benutzernamen (Login) in das Feld *Benutzername* und ein Passwort (wie von Ihrem Systemadministrator empfohlen) in das Feld *Passwort*.

Aus Sicherheitsgründen sollte Ihr Passwort mindestens acht Zeichen lang sein und sowohl Groß- als auch Kleinbuchstaben und Zahlen enthalten. Für Passwörter sind maximal 72 Zeichen zulässig und die Groß-/ Kleinschreibung ist zu beachten. Fahren Sie mit *Weiter* fort.

## 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of "copyleft", which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. We recommend this License principally for works whose purpose is instruction or reference.

## 1. APPLICABILITY AND DEFINITIONS

This License applies to any manual or other work, in any medium, that contains a notice placed by the copyright holder saying it can be distributed under the terms of this License. Such a notice grants a world-wide, royalty-free license, unlimited in duration, to use that work under the conditions stated herein. The "Document", below, refers to any such manual or work. Any member of the public is a licensee, and is addressed as "you". You accept the license if you copy, modify or distribute the work in a way requiring permission under copyright law.

A "Modified Version" of the Document means any work containing the Document or a portion of it, either copied verbatim, or with modifications and/or translated into another language.
