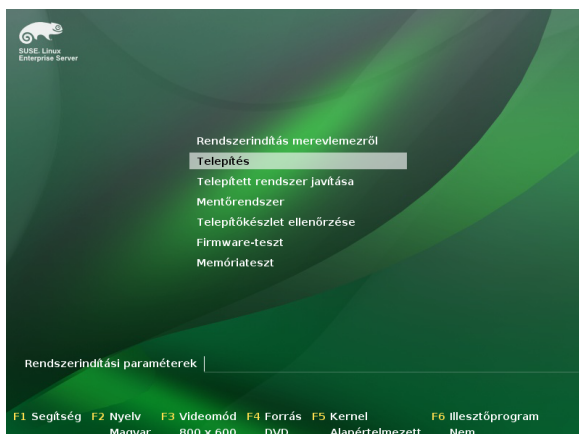
Minimális rendszerkövetelmények

- 800 x 600 képpont felbontású kijelző (legalább 1024 x 768 képpont ajánlott)

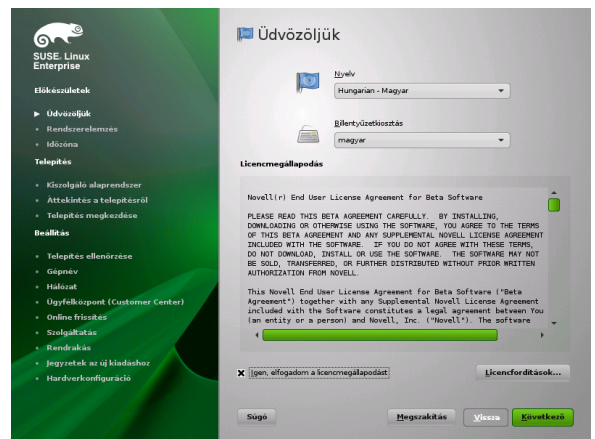
A SUSE Linux Enterprise Server telepítése

Az alábbi ismertető használata akkor javasolt, ha a számítógépen jelenleg nincs semmilyen Linux-rendszer, vagy a rajta lévő Linux-rendszer helyére kíván telepíteni.

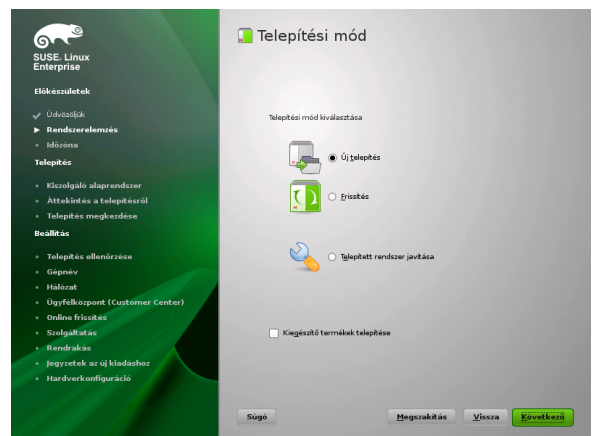
1. Helyezze be a meghajtóba a SUSE Linux Enterprise Server DVD-t, majd a telepítőprogram indításához indítsa újra a számítógépet. A hagyományos BIOS rendszerrel ellátott számítógépeken az alábbi rendszerindító képernyő látható. Az UEFI rendszerrel ellátott számítógépeken nem grafikus rendszerindító képernyőt használ a program. Az UEFI rendszerrel ellátott számítógépeken támogatott a biztonságos rendszerindítás.



2. A rendszerindítási képernyőn válassza a *Telepítés* pontot, majd nyomja meg az *Enter* billentyűt. Ennek hatására betöltődik a SUSE Linux Enterprise Server telepítőprogram, és normál módban elindul a telepítés.



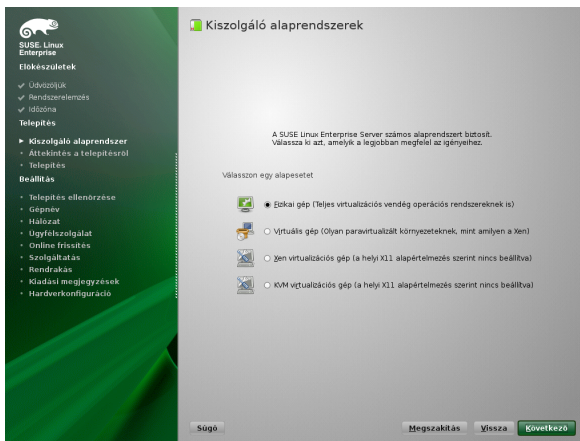
3. Válassza ki a nyelvet a telepítés és a telepített rendszer számára.
4. Olvassa el a Licenccserekeket, kattintson az *Igen, elfogadom a licenccserekeket* pontra. Kattintson a *Következő* gombra.



5. Döntse el, hogy *Új telepítés* menjen végbe, vagy a SUSE Linux Enterprise Server egy korábbi verzióját frissíti. Kattintson a *Következő* gombra.



6. Válassza ki a rendszerben használni kívánt órát és időzónát. Kattintson a *Következő* gombra.



7. Döntse el, hogy miképpen hajtja végre SUSE Linux Enterprise Server telepítését: a *Fizikai gép* beállítással, XEN-gép virtuális vendégrendszereként a *Virtuális gép* beállítással, illetve más virtuális gépeken futtatható virtuális gépként a *XEN virtualizációs gép* vagy *KVM virtualizációs gép* beállítással. Kattintson a *Következő* gombra.

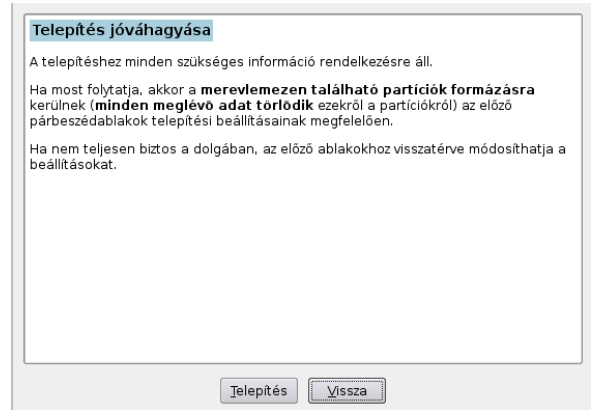


8. A *Telepítési beállítások* képernyőn tekintse meg a javasolt telepítési és particionálási beállításokat, és szükség esetén módosítsa azokat saját igényeinek megfelelően.

Az *Áttekintés* lap olyan alapvető beállítási lehetőségeket tartalmaz, amelyek a

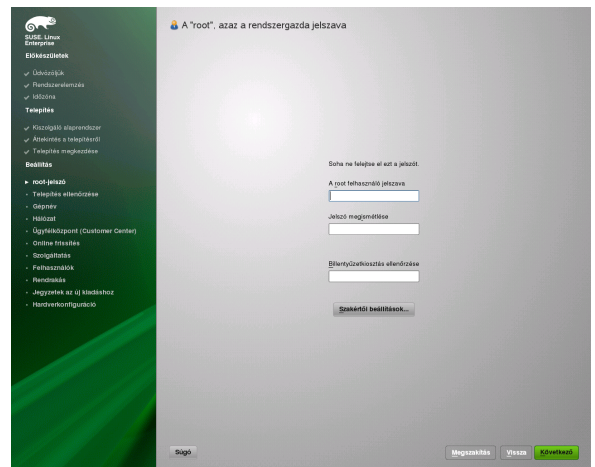
legtöbb általános telepítési helyzetben kézi beavatkozást igényelnek. A *Szakértői* lap speciális beállítási lehetőségeket tartalmaz.

9. A licen szerződés elfogadásához kattintson az *Elfogadom* lehetőségre.



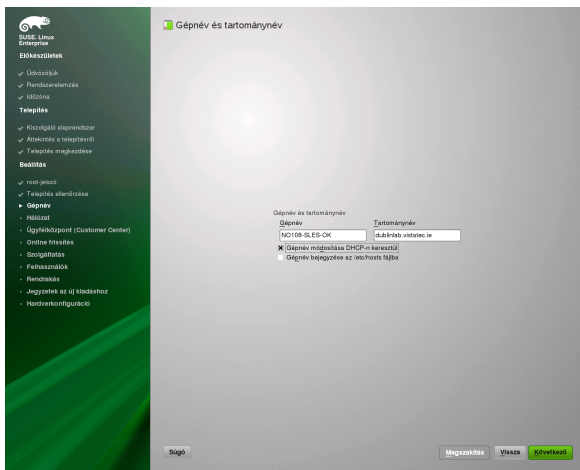
10. Kezdje meg a telepítést a *Telepítés* lehetőség használatával.

Miután megadta a rendszer alapvető beállításait, és telepítette az összes kiválasztott szoftvercsomagot, a SUSE Linux Enterprise Server telepítője elindítja az új Linux rendszert. Az újraindítás után a következő képernyőt fogja látni:

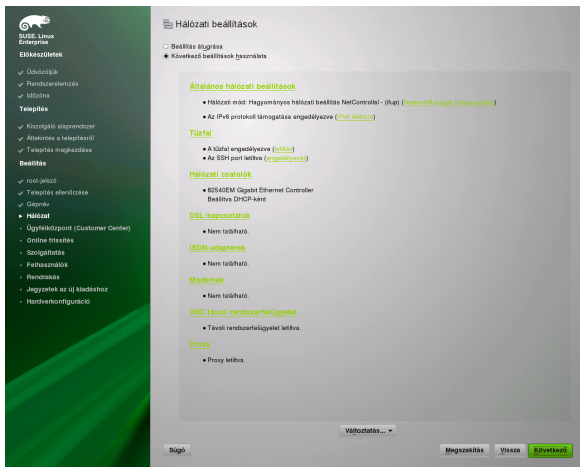


11. Írjon be egy jelszót a rendszergazdai fiók számára (ezt nevezik *root* felhasználónak).

Nem szabad elfelejtenie a *root* jelszót! Miután itt megadta, a jelszót nem lehet lekérni. Csak felügyeleti támogatással lehet visszaállítani. Nyomja meg a *Következő* gombot.

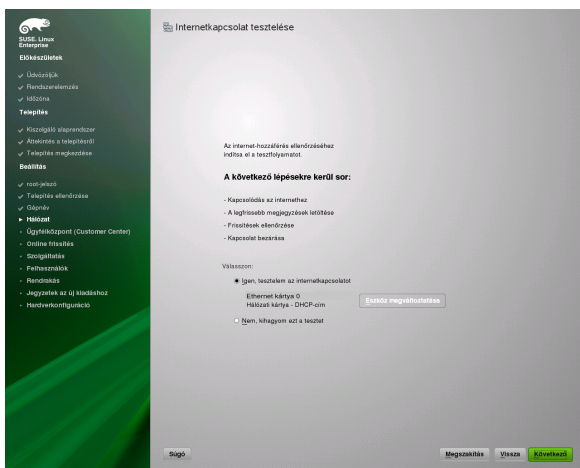


12. Adja meg a számítógéphez az *Állomásnév* és a megfelelő DNS *Tartománynév* beállítását. Kattintson a *Következő* gombra.



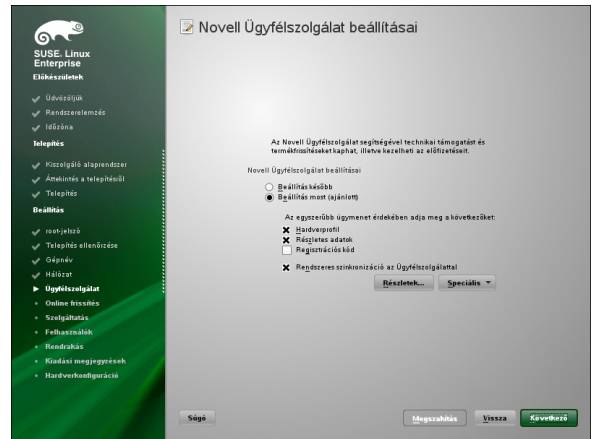
13. A *Hálózati beállítások* képernyőn tekintheti meg és módosíthatja a rendszer hálózati kapcsolatait.

Ha rendelkezik hálózati eszközökkel (például hálózati vagy vezeték nélküli kártyák, DSL-kapcsolat, ISDN-adapter vagy modem), célszerű azokat most konfigurálni, mivel egy internetkapcsolat lehetővé teszi a SUSE Linux Enterprise Server számára az esetleg rendelkezésre álló frissítések letöltését és beépítését a telepítésbe. Kattintson a *Következő* gombra.



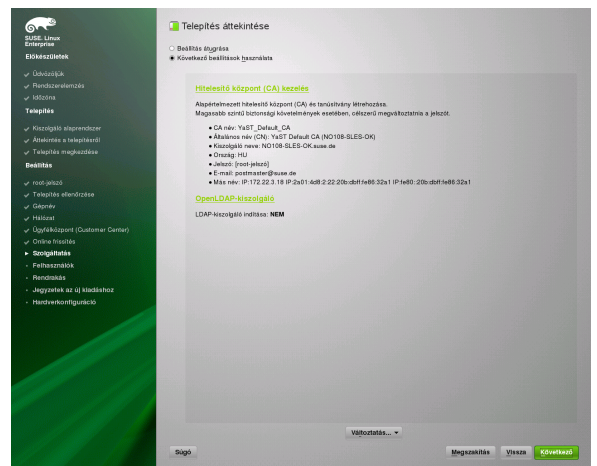
14. Az internetkapcsolat teszteléséhez kattintson az *Igen, tesztelem az internetkapcsolatot* gombra. Ez az opció megkeresi a SUSE Linux Enterprise Server legfrissebb kibocsátási megjegyzéseit is. Kattintson a *Következő* gombra.

15. A *teszt eredményét* Az internetkapcsolat tesztelése képernyőn tekintheti meg. Kattintson a *Következő* gombra.

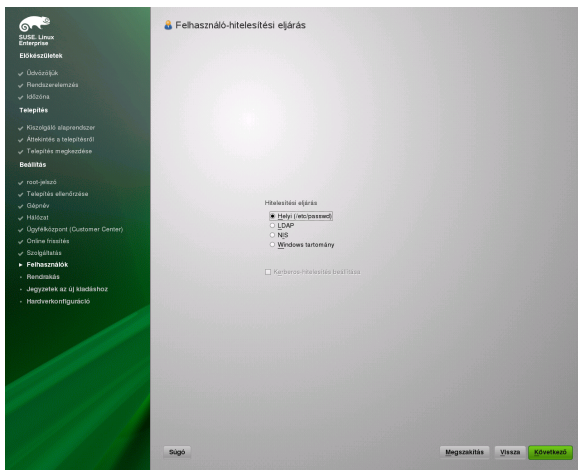


16. Engedélyezze a rendszer online frissítését a *Novell Ügyfélszolgálat konfigurálása* képernyőn, a *Beállítás most* → , a *Tovább* → és a *Folytatás* gomb segítségével.

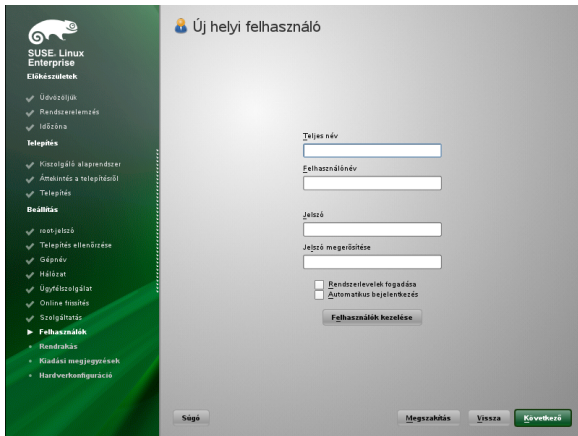
E lépés átugrásához és a telepítés folytatásához kattintson a *Beállítás később* → *Tovább* gombokra. Ennek az opciónak a konfigurálását a termék telepítése után is elvégezheti. Kattintson a *Következő* gombra.



17. A SUSE Linux Enterprise Server alapértelmezés szerint létrehoz egy tanúsítványt a rendszer számára. Ennek letiltásához kattintson a *Beállítás átugrása* → *Következő* gombokra. Kattintson a *Következő* gombra.

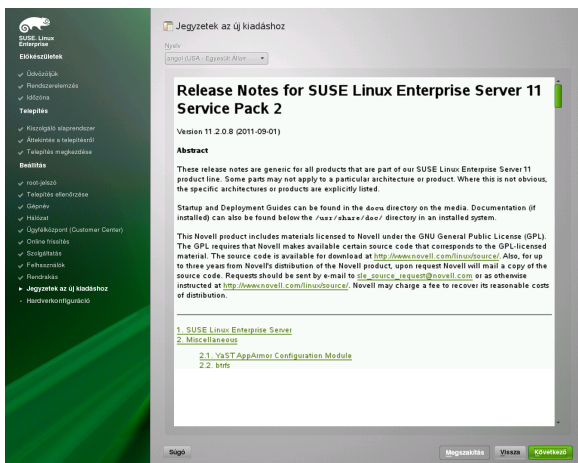


18. Válassza a *Local (/etc/passwd)* beállítást a Felhasználó-hitelesítési eljárás képernyőn, kivéve ha a rendszergazda ettől eltérő útmutatást ad. Kattintson a *Következő* gombra.

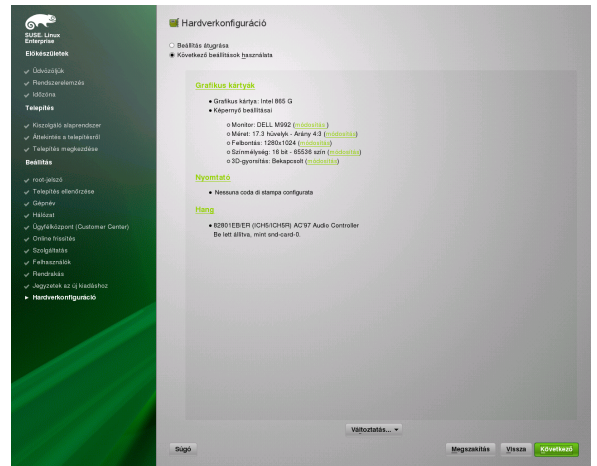


19. Írja be a vezeték- és utónevét a *Teljes név* mezőbe, egy bejelentkezési nevet a *Felhasználónév* mezőbe és egy jelszót (ahogy a rendszergazda javasolta) a *Jelszó* mezőbe.

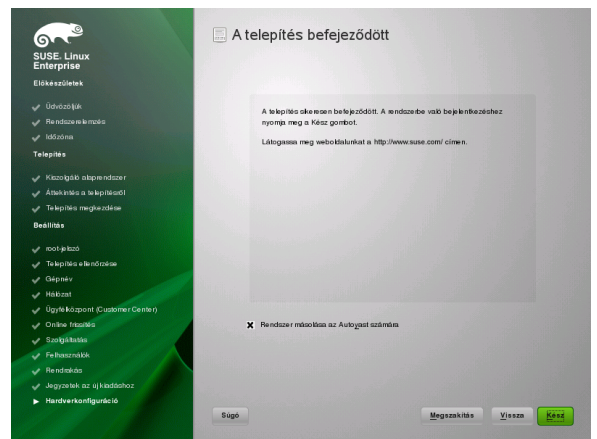
Biztonsági okokból a jelszó legalább nyolc karakter hosszú legyen, és tartalmazzon kis- és nagybetűket, valamint számokat. A jelszó kis- és nagybetűérzékeny, és legfeljebb 72 karakter hosszú lehet. Kattintson a *Következő* gombra.



20. A rendszer beállításának befejezése után olvassa el a kiadási megjegyzéseket. Kattintson a *Következő* gombra.



21. A Hardverkonfiguráció képernyő segítségével tekintheti meg vagy módosíthatja a videokártyát és más hardvereszközöket. Kattintson a *Következő* gombra.



22. A Telepítés befejeződött képernyőn a SUSE Linux Enterprise Server telepítésének bezárásához és a bejelentkezési képernyővel való folytatáshoz kattintson a *Befejezés* gombra.

23. Írja be a felhasználónevét, majd írja be a jelszavát a *Jelszó* mezőbe, ezután nyomja meg az Enter billentyűt.

0. PREAMBLE
