Aby zainstalować nową wersję systemu SUSE® Linux Enterprise Server 11 SP4, należy użyć poniższych procedur. Ten dokument zawiera krótkie omówienie domyślnej instalacji systemu SUSE Linux Enterprise Server w ramach architektury x86 i x86\_64.

## Minimalne wymagania systemowe

- Procesor Pentium\* III 500 MHz lub szybszy (zalecany procesor Pentium 4 2,4 GHz lub szybszy albo dowolny procesor o architekturze AMD64/Intel\* EM64T)
- Fizyczna pamięć RAM 512 MB (zalecana 1 GB)
- Dostępna przestrzeń dyskowa 2 GB (zalecana większa)
- Ekran o rozdzielczości 800 x 600 (zalecana 1024 x 768 lub większa)

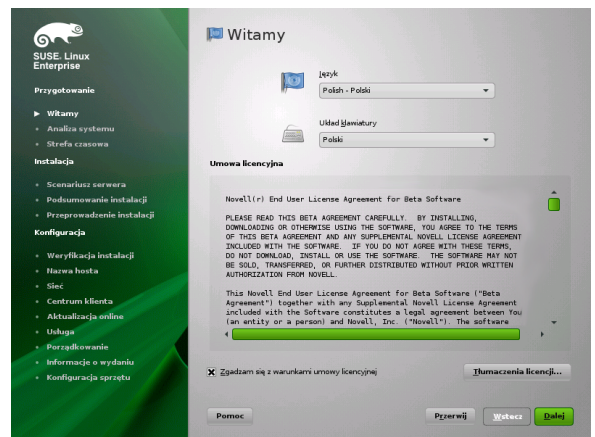
## Instalowanie systemu SUSE Linux Enterprise Server

Z tych instrukcji należy skorzystać, jeśli na komputerze nie ma systemu Linux lub jeśli istniejący system Linux ma zostać zastąpiony.

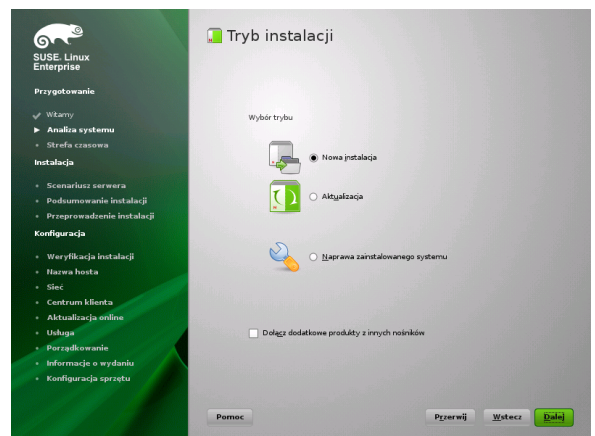
1. Umieść dysk DVD systemu SUSE Linux Enterprise Server w napędzie i zrestartuj komputer w celu uruchomienia programu instalacyjnego. Na komputerach z tradycyjnym systemem BIOS zostanie wyświetlony graficzny ekran startu systemu przedstawiony poniżej. W przypadku komputerów z interfejsem UEFI używany jest tekstowy ekran startu systemu. Na komputerach z systemem UEFI obsługiwany jest bezpieczny start systemu.



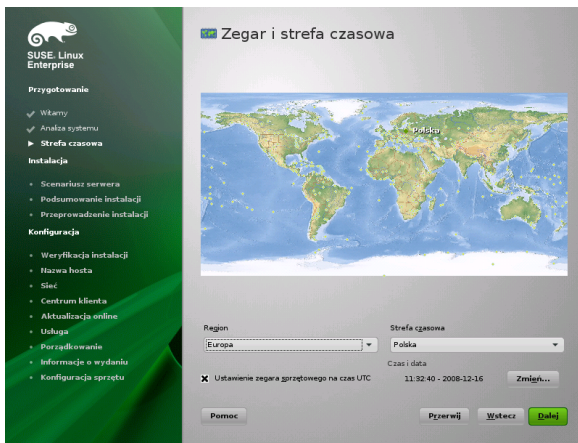
2. Proszę wybrać polecenie *Instalacja* z menu rozruchowego i nacisnąć klawisz Enter. Spowoduje to wczytanie programu instalacyjnego systemu SUSE Linux Enterprise Server, po czym rozpocznie się instalacja w trybie normalnym.



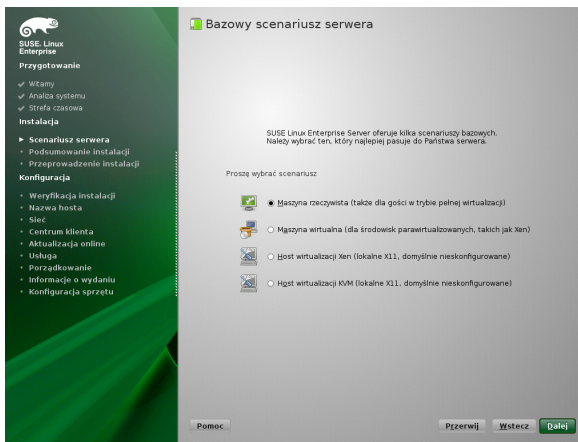
3. Proszę wybrać język, który ma być używany podczas instalacji i w zainstalowanym systemie.
4. Proszę przeczytać umowę licencyjną i zaznaczyć pole wyboru *Zgadzam się z warunkami umowy licencyjnej*. Proszę kliknąć przycisk *Dalej*, aby kontynuować.



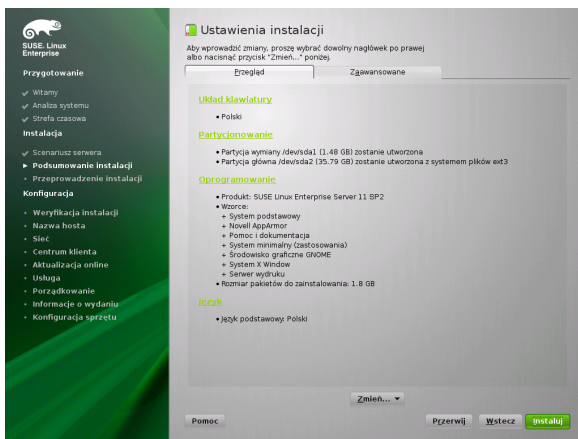
5. Proszę wybrać, czy ma być przeprowadzona *Nowa instalacja*, czy aktualizacja poprzedniej wersji produktu SUSE Linux Enterprise Server. Proszę kliknąć przycisk *Dalej*, aby kontynuować.



6. Proszę wybrać strefę czasową używaną dla danego komputera. Proszę kliknąć przycisk *Dalej*, aby kontynuować.



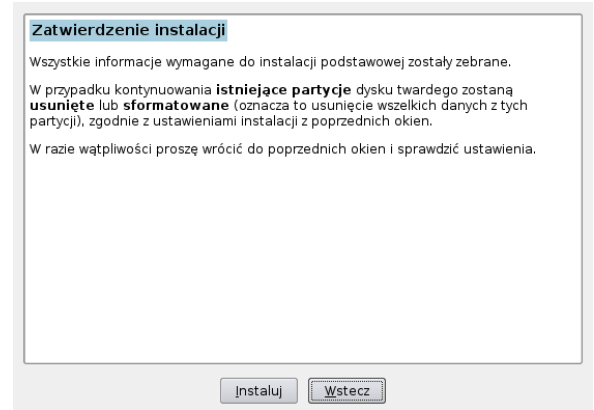
7. Należy zdecydować, czy system SUSE Linux Enterprise Server ma zostać zainstalowany na komputerze jako *Maszyna rzeczywista*, jako maszyna wirtualna (gość) w monitorze maszyn wirtualnych XEN (wybierając opcję *Maszyna wirtualna*), czy jako host wirtualizacji, który może uruchamiać inne maszyny wirtualne (opcje *Host wirtualizacji XEN* lub *Host wirtualizacji KVM*). Proszę kliknąć przycisk *Dalej*, aby kontynuować.



8. Ekranu *Ustawienia instalacji* można użyć do przeglądu zaproponowanych opcji instalacji i partycjonowania oraz do zmian poszczególnych opcji w razie potrzeby.

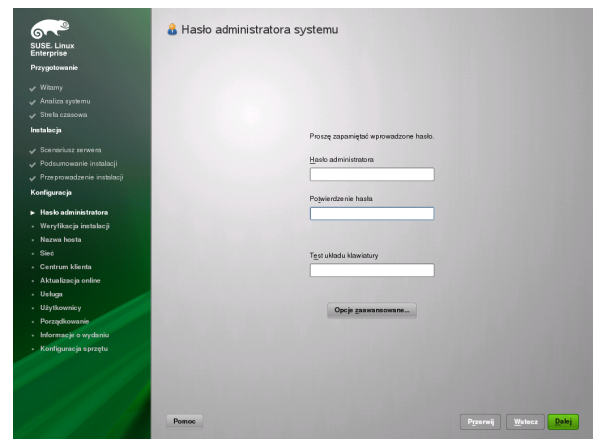
Karta *Przełgląd* zawiera podstawowe opcje wymagające interwencji ręcznej w większości typowych kontekstów związanych z instalacją. Karta *Zaawansowane* zawiera zaawansowane opcje konfiguracji.

9. Proszę kliknąć przycisk *Zaakceptuj*, aby zaakceptować umowy licencyjne.



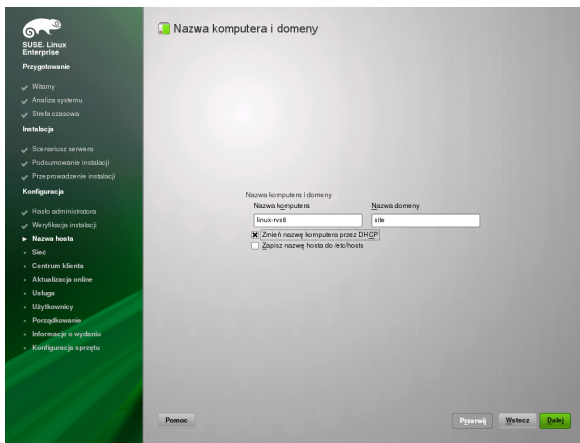
10. Aby rozpocząć instalację, trzeba kliknąć przycisk *Instaluj*.

Po ukończeniu podstawowej konfiguracji systemu i zainstalowaniu wszystkich wybranych pakietów oprogramowania program instalacyjny produktu SUSE Linux Enterprise Server uruchomi nowy system Linux. Po uruchomieniu wyświetlony zostanie następujący ekran:

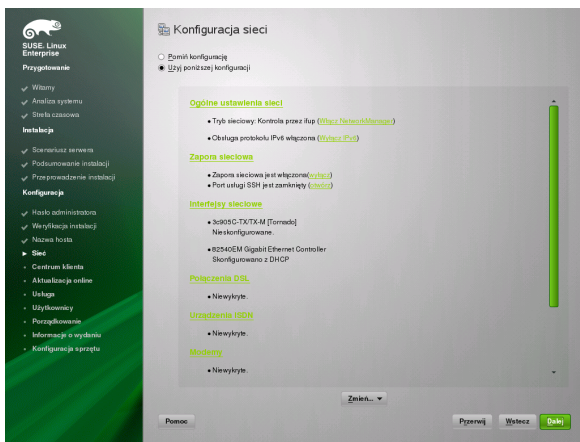


11. Proszę wpisać hasło administratora systemu (użytkownika *root*).

Hasła użytkownika *root* nie wolno zapomnieć! Po jego wprowadzeniu tutaj nie może być odzyskane. Można je ustawić na nowo tylko z pomocą administratora. Proszę kliknąć przycisk *Dalej*, aby kontynuować.

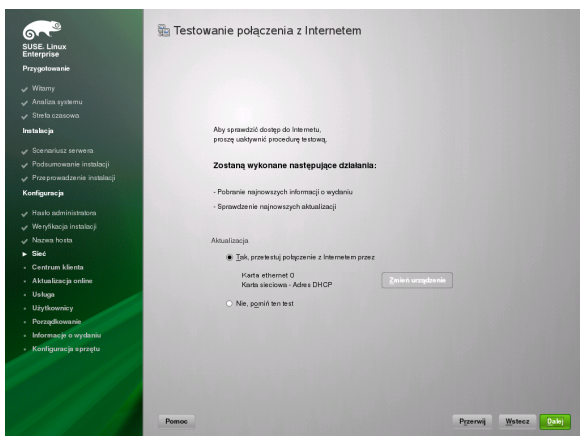


12. Następnie należy wypełnić pola *Nazwa hosta* dla danego komputera oraz *Nazwa domeny* DNS, do której on należy. Proszę kliknąć przycisk *Dalej*, aby kontynuować.



13. Na ekranie *Konfiguracja sieci* można przejrzeć lub zmienić połączenia sieciowe w systemie.

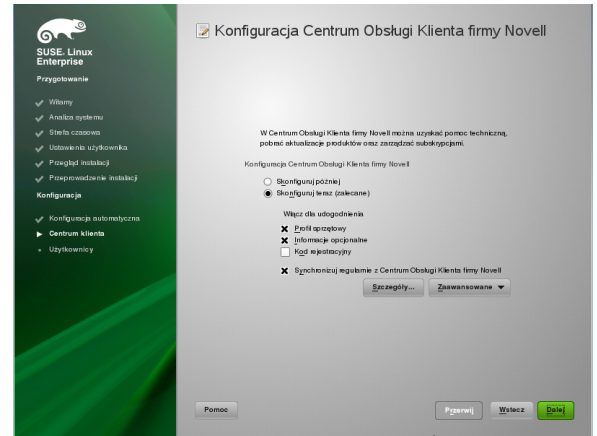
Jeśli komputer ma urządzenia sieciowe (np. kartę sieciową albo bezprzewodową, połączenie DSL, kartę ISDN lub modem), dobrze jest skonfigurować je teraz, ponieważ połączenie z Internetem pozwala produktowi SUSE Linux Enterprise Server pobrać wszelkie dostępne aktualizacje i dołączyć je do instalacji. Proszę kliknąć przycisk *Dalej*, aby kontynuować.



14. Połączenie z Internetem można sprawdzić za pomocą opcji *Tak, przetestuj połączenie*

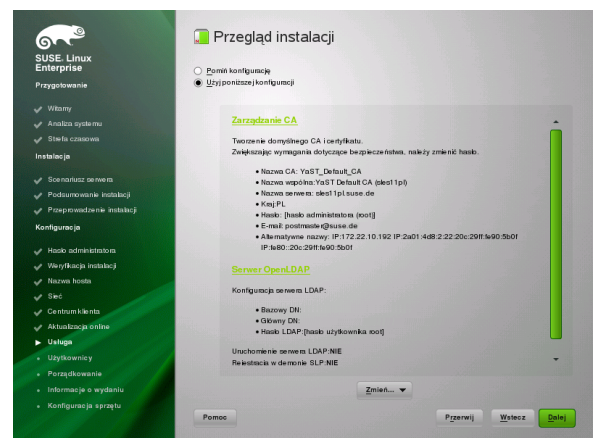

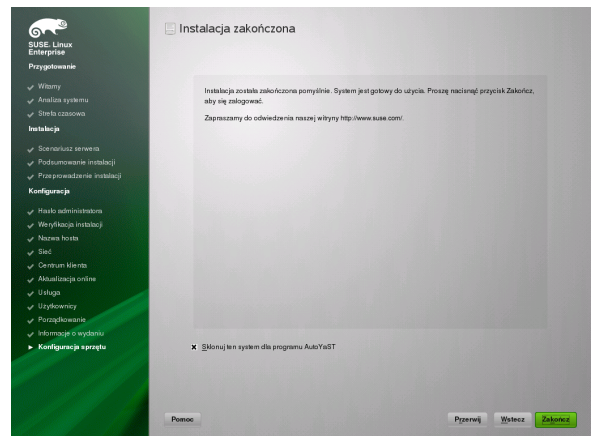
